 ability in patient care to establish a therapeutic relationship using empathetic listening and
 effective communication for various social backgrounds, perspectives, and levels of health
 literacy.
 - Student Doctor Doe's Student Initiative in Medical Simulation's team won regional competition, qualifying them for national competition and demonstrating her ability to communicate concerns and give feedback to peers in stressful situations. Spanish proficiency adds to her excellent communications skills, for which she commonly received 'beyond expectation' on clinical evaluations.
 - Student Doctor Doe has presented her research at multiple international and national
 conferences. She is published as the first author in the *Journal of Anatomical and Physiological*Studies where she presents a case report on Pericardial Cysts. She has also published her work
 on Cerebral Sinus Vein Thrombosis in journals such as Blood and ASHPO 2020 Paper and poster
 abstracts.


