 - Out of 100 Medicare patients, 13 completed a discussion about Advanced Directives and an Advance Care Plan



- By April 30, 2020, 50% of Medicare beneficiaries will complete a medication review and reconciliation.
 - 67% of patients completed a medication review and reconciliation



- By April 30, 2020, 25% of Medicare beneficiaries with pain will be screened for opioid misuse using the Opioid Risk Tool.
 - Five patients were identified as taking opioids and a risk assessment was completed



- By April 30, 2020, 90% of Medicare beneficiaries will be satisfied with the services received from Harris County Area Agency on Aging staff and Ibn Sina clinicians.
 - Our satisfaction survey shows that 90% of Medicare patients are "Highly Satisfied" with the services received from Ibn Sina and HCAAA

Conclusion



- Thirteen percent of patient participants completed a discussion about Advanced
 Directives and an Advance Care Plan compared to 3%, based on findings from Pelland,
 et. al. (2019)
 - Exceeded established goal
- 67 percent of patients received medication review and reconciliation compared to more than 32 percent of Medicare patients who had not spoken with their physician about medications in the previous 12 months (Wilson, et. al., 2007)
 - Exceeded established goal
- Only patients at risk for opioid misuse were screened using the opioid screening tool
 - The Opioid Risk Tool was not used, instead a series of questions developed by Texas Health and Human Services Commission was used to survey participants about opioid misuse
- The target for satisfaction with services rendered was achieved (90%)
