How To: CITI Registration and Affiliation

Step 1: Go to https://www.citiprogram.org

Then select *Register* OR *Log In* (if you already have an account) in the top right corner of the page.



If you already have an account with CITI, you can log into your account, go to the **My Courses** tab, then select **Add Affiliation** under the **Institutional Courses** section:
